NOTES TO FINANCIAL STATEMENTS**

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND OTHER INFORMATION

NATURE OF ACTIVITIES

Esophageal Cancer Education Foundation Inc. (the "Company") is a not-for-profit organization located in New Jersey.

The Company's mission is to bring awareness and educate the public and medical community about this dreaded disease, to walk the journey with patients who have this disease, and to financially support research projects that focus on the development of an early warning test for this disease.

BASIS OF ACCOUNTING

The accompanying financial statements of the Company have been prepared on the accrual basis of accounting.

BASIS OF PRESENTATION

Financial statement presentation follows the recommendations of the Financial Accounting Standards Board in its Accounting Standards Codification (ASC) No. 958, *Financial Statements of Not-for-profit Organizations*. Under ASC No. 958, the Center is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

CASH AND CASH EQUIVALENTS

The Company considers all highly liquid investments with maturities of three months or less at the date of purchase to be cash equivalents.

CONTRIBUTIONS

The organization accounts for contributions in accordance with the recommendations of the Accounting Standards Codification in ASC No. 958. In accordance with ASC No. 958, contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support, depending on the existence or nature of any donor restrictions.

PROPERTY AND EQUIPMENT

Property and equipment are recorded at cost. Depreciation and amortization has been provided on the straight-line method over the estimated useful life of the respective assets, which range from three to ten years.

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles includes the use of estimates that affect the financial statements. Accordingly, actual results could differ from those estimates.

SUBSEQUENT EVENTS

ASC 855 Subsequent Events sets forth general accounting and disclosure requirements for events that occur subsequent to the balance sheet date but before the company's financial statements are issued. We have evaluated events that have occurred through March 23, 2016 as prescribed by the FASB. ASC 855 emphasizes that management is primarily responsible for determining the accounting for and disclosure of transactions and events that affect the financial statements.

2. INCOME TAXES

The Company is a not-for-profit organization and is exempt from income taxes under Section 501 (C)(3) of the Internal Revenue Service Code.

3. ACCOUNTING FOR UNCERTAINTY IN INCOME TAXES

Esophageal Cancer Education Foundation Inc.'s current accounting policy is to disclose liabilities for uncertain tax positions when a liability is probable and estimable. Management is not aware of any violation of its tax status as an organization exempt from income taxes, nor is it aware of any exposure to unrelated business income tax. Esophageal Cancer Education Foundation Inc. is no longer subject to U.S. Federal, State and Local examinations by tax authorities for years before December 31, 2012.

4. FUNCTIONAL ALLOCATION OF EXPENSE

The costs of providing various programs and other activities have been summarized on a functional basis in the statements of activities. The allocation of said costs, based on Management's estimates and direct applications, is reflected in the Statement of Functional Expenses. Accordingly, certain costs have been allocated among the programs and supporting services benefited.
